# Section 4: First-Aid Measures

### Description of First Aid Measures

Eye Contact:

Immediately flush eyes with copious amounts of water. Remove any contact lenses. Rinse for at least 10 minutes. Get medical attention.

**Inhalation:** Remove victim to fresh air and maintain in a rest position comfortable for breathing. If
